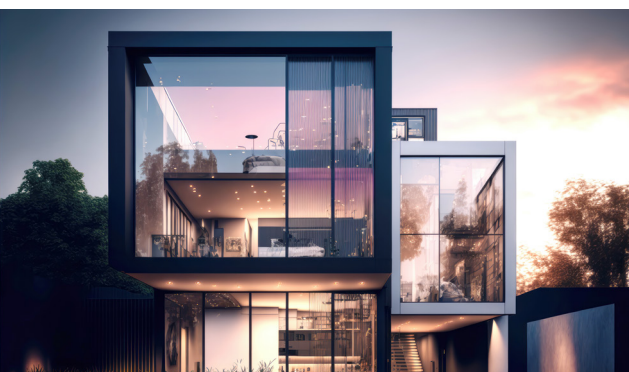

\$385 a year (includes GST)

Distributor Members are the manufacturers and/or distributors of window films.

Distributor member fees:
\$5,720 a year (includes GST)
